5.2.Learning tasks

Section 1. Civil law:

- Topic 1. Condominium. Community property. Process protection of property and possession.
- Topic 2. Contract property transfer. Commercial leases. Contractual obligations.
- Topic 3. Family business. Matrimonial property agreements. Regulating the rights of cohabiting couples.
- Topic 4. Proceding relating to annulment, divorce and legal separation.
- Topic 5. Family heritage. Wills, legitimate, successions agreements, trusts.

Section 2. Commercial and business law:

- Topic 1. Company law.
- Topic 2. Commercial and business contracts.
- Topic 3. Intellectual and industrial property protection.
- Topic 4. Insolvency law.
